



TUITION & FEES SCHEDULE

2010-2011 SCHOOL YEAR

TUITION

Tuition for the 2010-2011 school year will be \$8,250.

RE-REGISTRATION FEE

A registration fee is required at the time of re-registration and is non-refundable:

The re-registration fee is
\$125 before February 26, 2010 at 3 p.m.
& \$175 after February 26, 2010 at 3 p.m.

The registration fee must be paid for your student's registration to be complete. You will pay the registration fee when you re-register on-line with your debit or credit card, or by automatic funds transfer. **Students must be re-registered by March 15 to guarantee their space in the student body.**

TUITION PAYMENT PLANS

The following are your tuition payment options:

1. **Full payment** of tuition by July 15, 2010, with a 2.5% discount.
2. **Quarterly-payment option** through *FACTS* tuition payment plan with 25% due July 20, 2010; 25% due October 20, 2010; 25% due January 20, 2011; and 25% due April 20, 2011.
3. **Ten-month option** (August 2010 – May 2011) through *FACTS* tuition payment plan on the 5th, 15th, or 20th of each month.

The *FACTS* Tuition Payment Plan is an automatic cash transfer from your checking or savings account or by credit card. **For information about the new Credit Card payment option, please contact our finance office.** A copy of your 2010-2011 *FACTS* agreement will be mailed to you in late March. You will have an opportunity to make changes to that agreement (all changes must be submitted in writing to CVCA's finance office). If no written changes are received, your contract will be activated in late April. Upon activation, a one-time financing fee of \$38 will be deducted from your account for each *FACTS* contract. If financial aid is awarded, your contract will be adjusted to reflect that award and notice will be mailed before your first payment.

LATE ENROLLMENTS OR WITHDRAWALS

For changes in enrollment status during the year, tuition is prorated on a quarterly basis. Those students entering or withdrawing from CVCA during a given quarter will be charged for the full quarter.

OTHER STUDENT FEES

The graduation fee for the Class of 2011 is \$85. An athletic fee of \$125 is charged to each participant by the Athletic Office when students are named to team rosters (one fee covers all seasons). A \$200 fee is charged to students who have applied and been accepted to one of the Schools of Distinction. Student Parking Passes are \$40 for a year, or \$20 per semester. **(These fees are not due at re-registration).**

FINANCIAL AID

CVCA has a Financial Aid Program to assist families who otherwise might not be able to afford their tuition payments. In 2010, we will award \$775,000 in financial aid to our students. Financial aid is awarded using a needs-based evaluation of each applicant's family financial situation. Financial aid applications are available from the CVCA Finance Office after re-registration is complete. CVCA has engaged an outside agency, School Scholarship Service (SSS) to process all applications and evaluate a family's ability to pay tuition. All financial aid application information is held in strict confidence.

The deadline to submit a financial aid application is March 31, 2010

TUITION REDUCTION INCENTIVE PROGRAM

T.R.I.P. is a voluntary program whereby you can reduce your student's tuition while purchasing items you buy anyway. T.R.I.P. purchases bulk quantities of gift cards based on orders received from participating families. The families purchase the cards at face value with the bulk discount being passed on to individual accounts in the form of tuition credit. The list of over 200 participating stores includes gas, grocery, and retail stores, even airlines!
