Parental cooperation is needed. We understand that modesty is somewhat subjective in nature; however, we have established a description of modesty for girls' dresses that we believe is in keeping with the spirit of our appearance guidelines. This is our standard and we expect students and guests to know and to adhere to our standard.

LADIES: Dresses with the following characteristics **DO NOT** meet the modesty standard:

- Excessively tight/clingy material
- Backless
- Low cut, cleavage showing
- Hemline or slit more than 3 inches higher than the top of knee
- Midriff showing (2 piece dresses, mesh, cut-outs)

MEN:

- Attire for this event is suit and tie or dress pants, dress shirt, and tie.
- Male students and guests are not permitted to wear earrings to this CVCA sponsored event.
