CVCA juniors and seniors may invite outside guests to attend with the approval from Mrs. McMullen prior to ticket purchase. A CVCA sophomore invited by an upper classman must be approved by Mrs. McMullen prior to ticket purchase.

Prom is a time for fun, fellowship, and reflecting on good times at CVCA. Modesty for girls is a very significant consideration in selecting a stylish formal or dressy dress. Parental cooperation is needed. We understand that modesty is somewhat subjective in nature; however, we have established a description of modesty for girls' dresses that we believe is in keeping with the spirit of our appearance guidelines. This is our standard and we expect students and guests to know and to adhere to our standard.

**LADIES:** Dresses with the following characteristics DO NOT meet the modesty standard:

- Excessively tight/clingy material
- Backless
- Midriff showing (2-piece dresses, mesh, cut-outs)
- Low cut, cleavage showing
- Hemline or slit more than 3 inches higher than the top of knee

**MEN:** Attire for this event is suit and tie or dress pants, dress shirt, and tie.

- Male students and guests are not permitted to wear earrings to this CVCA sponsored event.
