# Cuyahoga Valley Christian Academy STATEMENT OF FAITH

- 1. We believe the Scriptures of the Old and New Testaments to be verbally inspired by God and inerrant in the original writings, and that they are the supreme and final authority in faith and conduct.
- 2. We believe in one God, eternally existent in three persons: Father, Son and Holy Spirit.
- 3. We believe in the deity of our Lord Jesus Christ; in His virgin birth; and His sinless life; in His miracles; in His atonement for our sins by His blood, shed when He died for us; in His bodily resurrection; in His ascension to the right hand of the Father; and in His personal, bodily, visible, imminent return to earth to establish His kingdom in power and glory.

We believe in the literal account of creation, and that the Scriptures clearly teach that Man was created by a special, immediate, formative act of God; that Adam and Eve sinned, and thereby brought on themselves not only physical death, but also spiritual death—separation from God; and that all human beings are born with this sinful nature.
