Some items offered at these locations may not be approved for everyday uniform wear.	<ul> <li>CVCA Polos (long or short- sleeved)</li> <li>CVCA Quarter-zips</li> <li>CVCA Hoodies</li> <li>CVCA Sweatshirts</li> <li>CVCA Letterman Jackets</li> </ul>	<ul> <li>All tops must be solid color black, royal blue, or gray, with the exception of white hoodies/sweatshirts. An approved CVCA logo must be visible on the front of the shirt. NO T-SHIRTS MONDAY-WEDNESDAY.</li> <li>Polos and quarter-zips (black, royal blue, gray, NO white)</li> <li>May wear a solid color (white, royal blue, black, or gray) crew neck shirt (short/long-sleeved) under polo or quarter-zip</li> <li>Long-sleeved hoodies/sweatshirts/full-zip (black, royal blue, grey, white) – Must have in-code tops underneath if outer layer is removed.</li> <li>Must wear in-code top under letterman jacket</li> <li>No other outerwear may be worn during the school day</li> </ul>
HIGH SCHOOL HOUSE and MIDDLE SCHOOL GRADE LEVEL SPIRIT WEAR Thursdays ONLY	High School House/ Middle School Grade- level T-shirts (long or short-sleeved)	<ul> <li>High School House/Middle School Grade-level T-shirts (long or short-sleeved) may be worn on Thursdays.</li> <li>Students who do not wish to wear house or grade-level shirts must wear regular Monday-Wednesday SAS apparel.</li> <li>May wear solid long-sleeved shirt underneath a House/Class T-shirt</li> <li>NO patterns, letters, words, stripes, or thermal underwear</li> </ul>
CVCA SPIRIT WEAR Fridays ONLY	CVCA Spirit Wear T-shirts (long or short- sleeved)	<ul> <li>Any CVCA Spirit Wear is permitted on Fridays only</li> <li>Includes T-shirts, long-sleeved T-shirts, sweatshirts</li> <li>Any colors/patterns approved through CVCA clubs, houses, grade levels permitted</li> <li>May wear solid long-sleeved shirt underneath a CVCA Spirit Wear T-shirt</li> <li>NO patterns, letters, words, stripes, or thermal underwear</li> </ul>
PANTS	Docker, Jogger, Cargo, Khaki Style	<ul> <li>Non-athletic full-length pants.</li> <li>Solid color tan khaki or black ONLY (no grey/faded black)</li> <li>No sweatpants, leggings, yoga pants, or tights</li> <li>Shorts are not permitted</li> <li>Modest and appropriate fit for school culture</li> </ul>
SHOES	Closed-toe Shoes	<ul> <li>Shoes must be clean and in good repair</li> <li>Socks must be worn</li> <li>Shoes must have soles</li> <li>No sandals/slides, Crocs, slippers, rain boots, five-fingers, or vented water shoes</li> </ul>
SOCKS	Required	Any style/color that maintains a respectful design is appropriate (i.e., footie, crew, knee-length)
BELTS	Encouraged but not required	Solid color: black, brown, gray or white
HAIR	<ul><li>Neat and well- groomed</li><li>Natural color</li></ul>	<ul> <li>Please contact the Main Office BEFORE getting a questionable hairstyle or change in color.</li> <li>Hair must be styled so that eyes are NOT covered (Students may be asked to pull hair back)</li> <li>No extreme hair styles (i.e., shaved portions, spikes, etc.)</li> <li>No unnatural colors (i.e., blue, pink, green, etc.)</li> <li>Facial hair is permitted as long as it is neatly trimmed and well-groomed</li> </ul>
MEN ADDITIONAL GUIDELINES	<ul> <li>May wear a reasonable amount of business-attire jewelry (No earrings; Jewelry should not be excessive)</li> <li>Tattoos should not be visible at any time</li> <li>May NOT wear make-up, including nail polish</li> <li>Hats and hoods are NOT to be worn in the building at any time</li> <li>Bandannas and scarves are NOT to be worn during school hours</li> <li>Pant and shirt chains are not permitted</li> <li>No blankets</li> <li>Clothing should not be ripped, cut, or modified in any way. (example: removing the neckline of a sweatshirt)</li> </ul>	
LADIES ADDITIONAL GUIDELINES	<ul> <li>May wear a reasonable amount of business-attire jewelry (should not be excessive)</li> <li>Pierced body parts, other than ears, are NOT in code (must wear a clear spacer for nose piercing)</li> <li>Tattoos should not be visible at any time</li> <li>Make-up should be modest and not draw unnecessary attention</li> <li>Hair accessories must be school appropriate – no tinsel</li> <li>Hats and hoods are NOT to be worn in the building at any time</li> <li>Bandannas and scarves are NOT to be worn during school hours</li> <li>Pant and shirt chains are not permitted</li> <li>No blankets</li> <li>Clothing should not be ripped, cut, or modified in any way. (example: removing the neckline of a sweatshirt)</li> <li>No midriff or cleavage showing (wear undershirts when appropriate)</li> </ul>	

# **Enforcement of Student Appearance Standards**

## First Office Referral: Warning

- 1. An email is sent to parents informing them of the nature of the SAS infraction and that a second infraction will result in two lunch detentions.
- 2. Documentation of the violation is recorded in Facts SIS (formerly RenWeb).

NOTE: If a student is unable to correct the violation, they may be asked to remain in the Office until it can be corrected.

## Second Office Referral:

- 1. An email is sent to parents informing them of the nature of the SAS infraction and that a third infraction will result in an extended office detention.
- 2. The student receives two lunch detentions.
- 3. Documentation of the violation is recorded in Facts SIS (formerly RenWeb).

NOTE: If a student is unable to correct the violation, they may be asked to remain in the Office until it can be corrected.

## Third Office Referral and Beyond:

- 1. An email is sent to parents informing them of the nature of the SAS infraction and that any subsequent infraction will result in an extended office detention.
- 2. The student receives an extended office detention, with the potential loss of PRT.
- 3. Documentation of the violation is recorded in Facts SIS (formerly RenWeb).

NOTE: If a student is unable to correct the violation, they may be asked to remain in the Office until it can be corrected.
